Structural Findings:

Based on a review of the provided data, conditions indicate a moderate structural defect to the floor framing at the kitchen. The amount of movement (about 1 1/2" floor differential) is of moderate concern. Other areas of the structure appear to be sound.

Structural Recommendations:

We recommend monitoring floor conditions for changes such as increased floor movement or cracks to finishes in the area. If conditions change, further investigation is recommended. Although there is no indication that structural repairs are warranted at the present time, a possible future repair scenario would be reinforcing the joists at the area of floor settlement, such as by sistering of joists or similar.

Possible Repair Scenarios:

Reinforce floor joists at kitchen.
