GRAMMAR

THE VERB

The verb is the most important word in a sentence. It tells us what is happening and who is doing it. Verbs can be divided into two main groups: **action verbs** and **linking verbs**.

Action Verbs: These verbs show an action or a state of being. They can be transitive (they take an object) or intransitive (they do not take an object).

Linking Verbs: These verbs connect the subject to the predicate. They do not show an action or a state of being. Examples include 'is', 'was', 'seems', and 'feels'.

Verbs are also classified by their tense, which indicates when the action took place. The three main tenses are **present**, **past**, and **future**.

SENTENCES

A sentence is a group of words that expresses a complete thought. It must have a subject and a predicate. Sentences can be simple, compound, or complex.

Simple Sentences

A simple sentence has one independent clause. It can be written in four basic patterns:

- Subject + Verb (e.g., The cat slept.)
- Subject + Verb + Object (e.g., The cat ate the fish.)
- Subject + Verb + Complement (e.g., The cat was happy.)
- Subject + Verb + Adverb (e.g., The cat slept peacefully.)

Compound Sentences

A compound sentence has two or more independent clauses joined by a coordinating conjunction (and, but, or, so, for, yet, nor).

Complex Sentences

A complex sentence has one independent clause and one or more dependent clauses. The dependent clause is introduced by a subordinating conjunction (because, when, if, although, since, as, after, before, until, while, unless, even though, in order to, so that, as if, as though, as though, as if).

ADJECTIVES

Adjectives describe nouns. They tell us what something is like, how many there are, or which one it is. Adjectives can be placed before or after the noun they describe.

ADVERBS

Adverbs describe verbs, adjectives, or other adverbs. They tell us how, when, where, or how often something happens. Adverbs can be placed before or after the word they describe.

PREPOSITIONS

Prepositions show the relationship between a noun or pronoun and another word in a sentence. They are often used to show location, time, or direction.

SENTENCE STRUCTURE

The structure of a sentence refers to the order of its parts. Understanding sentence structure helps you write more effectively and understand what you read.

Subject-Verb Order

The most common sentence structure is Subject-Verb (S-V). For example: 'The cat slept.' This structure is used in most simple sentences.

Verb-Subject Order

Verb-Subject (V-S) order is used in imperative sentences (commands) and some questions. For example: 'Sleep peacefully.' or 'Did the cat sleep?'

Object-Subject Order

Object-Subject (O-S) order is used in questions. For example: 'Who ate the fish?'

Complement-Subject Order

Complement-Subject (C-S) order is used in questions. For example: 'What was the cat like?'

EMPHASIS & CHANGING MEANINGS

Changing the order of words in a sentence can change its meaning or emphasis. For example, 'The cat ate the fish' and 'The fish was eaten by the cat' have the same meaning but different emphasis.

SENTENCE FLUENCY & PARALLELISM

Parallelism is the use of similar grammatical structures in a sentence. It makes writing clearer and more effective. For example: 'She likes reading, swimming, and hiking.'

Parallel Structure

Parallel structure means using the same grammatical form for items in a list or series. For example: 'He likes to read, to swim, and to hike.' or 'He likes reading, swimming, and hiking.'

Parallelism in Lists


When listing items, use parallel structure. For example: 'The team consists of a captain, a coach, and several players.'

Parallelism in Sentences

Use parallel structure in compound and complex sentences. For example: 'After finishing the race, she felt tired and hungry.'
