Introduction

Companies raise funds to finance their operations by selling equity securities (common and preferred stock) and debt securities (bonds and notes). In this chapter, we will be looking at these securities from the perspective of the investing (purchasing) company.

General principles

From the investing company's perspective, an investment in a financial instrument is an _____.

In its simplest form, when an investment is made, the company is using an asset (cash) to acquire an asset (the investment).

The accounting for investments is driven by:

1. Whether the investment is a debt or equity security
2. The investor's purpose for holding the investment
3. The nature of the investment relationship

Debt investments

In a debt security, the investing company is effectively loaning money to the issuing (selling) company. We will use a bond for our discussion.

The price of a bond investment is determined by two cash flows:

1. A bond has a specified date when it matures. On that maturity date, the principal (also called the face amount or maturity value) is paid to investors.
2. During the holding period, investors receive interest payments (usually semi-annually) equal to some stated interest rate.

The price (or cost) of an investment in a bond is the _____ of these cash flows.

These cash flows are discounted using the _____ interest rate, which is the interest rate demanded by the market for investments with similar risk.

Bond price = (face amount x PV factor) + (interest payments x PV factor)

The PV factors come from present values tables in the textbook.
