- **Article XX (general exceptions) may provide a “safe harbor” for trade measures. However, the measures must conform to the demanding chapeau of the Article. The chapeau of GATT Article XX reads:**

*“Subject to the requirement that such measures are not applied in a manner which would constitute a means of arbitrary or unjustifiable discrimination between countries where the same conditions prevail, or a disguised restriction on international trade, nothing in this Agreement shall be construed to prevent the adoption or enforcement by any contracting party of measures...”*
