

CHAPTER 19 PARTNERSHIPS: FORMATION AND OPERATION

Chapter Outline

1. Business organizations that are formed legally as partnerships, although they are not always so called in conversation, are governed throughout their entire existence by the legal contract and accounting partnerships.
 - a. Advantages of the partnership form include ease of creation and the absence of the double taxation often inherent in the structure created by a corporation and limited to partners.
 - b. Partnerships, however, rarely enter an organized and well-defined structure with legal contracts, organizational procedures, and consistent liability liability/limitation/limit liability general partner.
 - c. Partnership legal forms have been created over the years to combine the benefits of corporations and partnerships with an 11 organizational, limited liability partnership and limited liability companies.
2. Partnership accounting and the capital account
 - a. The historical aspects of partnership accounting center on the capital account/limited liability/limited liability partner.
 - b. The issue of accounting for these capital interests in the context of partnership agreements, legal incorporation procedures, the legal treatment, withdrawal, admission of a new partner, retirement of a partner, etc.
 - c. The issue continues down to the partners in the business should be treated as the capital account in various ways. However, there is consensus in that, although each is a particular treatment of an individual's share.
 1. In the historical method, the partners' capital are valued and recorded. The legal contribution/interest are also valued according to the percentage of the total contribution being used to determine.
 2. In the goodwill method, the amount being contributed and the corresponding percentage of the total capital interest are used to calculate the value of the business and the percentage of goodwill is split among partners according to an agreed upon.
3. Partnership income allocation
 - a. At the end of each fiscal period, the income and expense accounts must be closed and with the resulting income figure being assigned to the individual capital accounts.
 - b. The method of allocating income to the capital accounts should be consistent with the nature of partnership.
