

## Case Study

A 3-month-old boy who has been hospitalized in the intensive care nursery since birth is recovering from corrective congenital heart surgery. The infant develops signs of sepsis. It is noted that a central line has been in place for some time, through which heparin has been given to reduce clot formation. A blood culture specimen drawn through the line tests positive. Subsequently, a second culture specimen is collected from a peripheral stick. Both specimens grow a gram-negative rod. The child is diagnosed with catheter-related bacteremia; antibiotics and removal of the catheter succeed in clearing the infection.

1. A commercial system identified the gram-negative bacilli as *Acinetobacter* sp.; however, it indicated that all the biochemical tests in the system, including utilization of glucose, were negative and the identification should be confirmed. What rapid biochemical tests should be used to confirm the identification?

Since all the biochemical tests in the said system resulted negative, other tests to confirm the identified gram-negative bacilli *Acinetobacter* sp. includes oxidase test wherein the expected result should be negative and a positive result on catalase test.

2. The isolate did not grow on MacConkey agar. Which test is needed to separate this genus from NO-1?

The test that is needed to separate this genus from CDC group NO-1 is nitrate reduction test. *Acinetobacter* sp. is not capable of reducing nitrate to nitrite while CDC group NO-1 can for they have the enzyme nitrate reductase.

3. How did the patient acquire the infection with this microorganism?

*Acinetobacter* sp. are known to be ubiquitous and opportunistic as it commonly causes nosocomial infections. Moreover, in hospitals they are associated in ventilators, humidifiers, catheters and other devices. Therefore, in this case, the patient acquired the infection through the catheter.

4. What is the meaning of a glucose-oxidizing, gram-negative rod?

A glucose-oxidizing, gram-negative rod is a type of bacilli that is capable of metabolizing carbohydrate particularly glucose and at the same time, tend to lose the crystal violet stain upon processing on the Gram staining method, a characteristic shared by bacteria that has a single, thin layer of peptidoglycan on its cell wall.

5. What is the best method of distinguishing an asaccharolytic microorganism from a fastidious gram-negative rod that is unable to grow in of media?

When asaccharolytic microorganism and fastidious gram-negative rod are both unable to grow on media, the best method to distinguish them is through the Oxidation-Fermentation Test, a method used to identify whether a gram-negative bacteria is capable to oxidize or ferment a specific carbohydrate.
