- Is an event with some degree of uncertainty
- "A discrete occurrence that may affect the project for good or bad."

Pure Risk or Insurable

- Pure risk is an insurance risk Only a risk of loss (e.g., fire, theft, personal injury)

Business Risk

- Risk of a gain or loss.
