✓ if a check "bounces", a holder can resubmit it but must first ____ of the first dishonor (or they are discharged).

✓ Once a bank agrees to accept overdrafts, refusal to honor checks on an overdrawn account is ____.

liable -

✓ if the bank has notice from a customer about a postdated check, the bank is ____.

*they have the right to refuse to accept if the date is wrong.
