

Advanced Financial Accounting and Reporting: PARTNERSHIP LIQUIDATION

Introduction

There are a lot of possible scenarios that can be asked in partnership liquidation. There is no one approach that you can use to all problems. As such, you need to expose yourself to different problems (i.e., rule on maximum exposure) so as not to be easily overwhelmed. Note that preparation of schedules in partnership is just like posting the journal entries that you have made. As such you will expect a comprehensive solution that will be presented but a shortcut will be presented later on. At a minimum, you need the following in answering problems related to partnership liquidation:

1. English comprehension
2. Basic accounting (e.g., journal entries – adjusting vs. closing, types of accounts, basic accounting equation)
3. Mathematics
 - a. Basic operation including PMDAS rule.
 - b. College algebra
 - c. Mathematics of investment (e.g., interest computation (Prt), present value computation)
4. Rules provided by the Civil Code. This is also discussed in your RFBT.
5. Rules in your other subject like revaluation under PAS 16 and 38, write-down of inventory under PAS 2, impairment of assets under PAS 36, among others.
6. Diligence, patience, eagerness, and right mental attitude in learning.

Partnership Liquidation

Liquidation is the winding up of the partnership business. This involves:

1. Converting non-cash assets into cash (i.e., realization)
2. Settlement of liabilities (i.e., liquidation)
3. Distribution of any remaining amount to the partners

Basic Concepts on Partnership Liquidation

1. *Unlimited Liability* – partners have unlimited liability hence external creditors can run after their separate personal property in case the partnership asset is insufficient to satisfy their claims. The personal creditors; however, of a partner is preferred over partnership creditors with respect to the personal assets of a partner. When a partner is personally insolvent and has capital deficiency, the other solvent partners absorbs his capital deficiency.
2. *Right of offset* – the right of a partner to set-off his loan to the partnership against his capital deficiency

Steps to a partnership's liquidation

1. Any operating income or loss up to the date of the liquidation should be computed and allocated to the partner's capital accounts on the basis of their P&L ratio.
2. All noncash assets are converted to cash. The gain (loss) realized on the sale of such assets is allocated to the partners based on their P&L ratio.
3. Any creditors' claims, including liquidation expenses or anticipated future claims, are satisfied through the payment or reserve of cash.
