### **Introduction**

### **Partnership Liquidation**

Liquidation is the winding up of the partnership business. This involves:

1. Converting non-cash assets into cash (i.e., realization)
2. Settlement of liabilities (i.e., liquidation)
3. Distribution of any remaining amount to the partners

### **Basic Concepts on Partnership Liquidation**

1. *Unlimited Liability* – partners have unlimited liability hence external creditors can run after their separate personal property in case the partnership asset is insufficient to satisfy their claims. The personal creditors; however, of a partner is preferred over partnership creditors with respect to the personal assets of a partner. When a partner is personally insolvent and has capital deficiency, the other solvent partners absorbs his capital deficiency.
2. *Right of offset* – the right of a partner to set-off his loan to the partnership against his capital deficiency

### **Steps to a partnership's liquidation**

1. Any operating income or loss up to the date of the liquidation should be computed and allocated to the partner's capital accounts on the basis of their P&L ratio.
2. All noncash assets are converted to cash. The gain (loss) realized on the sale of such assets is allocated to the partners based on their P&L ratio.
3. Any creditors' claims, including liquidation expenses or anticipated future claims, are satisfied through the payment or reserve of cash.
