

# Corporate Social Responsibility (CSR)

## Introduction

**Corporate Social Responsibility (CSR)** is a concept whereby companies consider not only their profitability and growth, but also the interests of society and the environment. Businesses take responsibility for the impact of their activities on various stakeholders – including the environment, consumers, employees, communities, and other members of the public sphere. In essence, CSR means that companies integrate social and environmental concerns in their business operations and interactions with stakeholders.

## Applicability of CSR Provisions

Section 135(1) of the Companies Act, 2013 prescribes that CSR requirements apply to companies that meet any **one** of the following criteria in the **immediately preceding financial year**:

- **Net Worth** of ₹500 crore or more; **or**
- **Turnover** of ₹1000 crore or more; **or**
- **Net Profit** of ₹5 crore or more.

These criteria apply to **all companies** (including foreign companies with branches or project offices in India). According to the CSR Rules, the CSR provisions also extend to any holding or subsidiary of a company that meets the criteria.

Once a company falls within the CSR criteria, it is required to **constitute a CSR Committee** of the Board and comply with the CSR provisions of the Act and rules.

## CSR Committee

Every company that meets the above criteria must constitute a CSR Committee. The CSR Committee is a Board committee dedicated to overseeing and guiding the company's CSR activities. The **composition** of the CSR Committee varies by company type, as follows:

Type of Company	CSR Committee Composition ( <i>Rule 5(1) of the Companies (CSR Policy) Rules, 2014</i> )
Listed company	At least 3 directors, of which at least 1 director must be an <b>independent director</b> .
Unlisted public company	At least 3 directors, of which at least 1 must be an independent director. <i>However, if the company is not required by law to appoint an independent director, then the CSR Committee may consist of 2 or more directors (with no independent director required).</i>
Private	At least 2 directors. ( <i>No independent director is required in the CSR Committee</i> )
