$$|\vec{a} - \vec{b}| < |\vec{a}| + |-\vec{b}|$$

$$|\vec{a} - \vec{b}| < |\vec{a}| + |\vec{b}| \quad \dots(\text{iii})$$

If the two vectors act in a straight line but in opposite directions, then we can write:

$$|\vec{a} - \vec{b}| = |\vec{a}| + |\vec{b}| \quad \dots(\text{iv})$$

Combining equations (iii) and (iv), we get:

$$|\vec{a} - \vec{b}| \leq |\vec{a}| + |\vec{b}|$$

**(d)** Let two vectors  $\vec{a}$  and  $\vec{b}$  be represented by the adjacent sides of a parallelogram PQRS, as shown in the given figure.

The following relations can be written for the given parallelogram.

$$OS + PS = OP \quad \dots(\text{i})$$

$$OS = PS - OP \quad \dots(\text{ii})$$

$$|\vec{a} - \vec{b}| > |\vec{a}| + |\vec{b}| \quad \dots(\text{iii})$$

The quantity on the LHS is always positive and that on the RHS can be positive or negative. To make both quantities positive, we take modulus on both sides as:

$$|\vec{a} - \vec{b}| > |\vec{a}| - |\vec{b}|$$


$$|\vec{a} - \vec{b}| > |\vec{a}| - |\vec{b}| \quad \dots(\text{iv})$$

If the two vectors act in a straight line but in the opposite directions, then we can write:

$$|\vec{a} - \vec{b}| = |\vec{a}| - |\vec{b}| \quad \dots(\text{v})$$

Combining equations (iv) and (v), we get:

$$|\vec{a} - \vec{b}| \geq |\vec{a}| - |\vec{b}|$$

- (a)  $\vec{a}$ ,  $\vec{b}$ ,  $\vec{c}$ , and  $\vec{d}$  must each be a null vector,
- (b) The magnitude of  $(\vec{a} + \vec{c})$  equals the magnitude of  $(\vec{b} + \vec{d})$ .
- (c) The magnitude of  $\vec{a}$  can never be greater than the sum of the magnitudes of  $\vec{b}$ ,  $\vec{c}$ , and  $\vec{d}$ .
- (d)  $\vec{b} + \vec{c}$  must lie in the plane of  $\vec{a}$  and  $\vec{d}$ , if  $\vec{a}$  and  $\vec{d}$  are not collinear, and in the line of  $\vec{a}$  and  $\vec{d}$ , if they are collinear?

(a) Incorrect

In order to make  $\vec{a} + \vec{b} + \vec{c} + \vec{d} = \vec{0}$ , it is not necessary to have all the four given vectors to be null vectors. There are many other combinations which can give the sum zero.
