Current Liabilities

Employee Related Liabilities

Liabilities resulting from the relationship between the employer and employee

Current liabilities related to employee compensation pay include:

- Payroll liabilities
- Compensation liabilities
- Pension

Payroll Liabilities

These liabilities are accrued for the services provided by employees and are measured periodically according to the amount due.

Social Security Taxes (FICA) (Section 1-100)

- FICA is a tax levied on the wages and salaries received by employees (FICA) for the use of Social Security and Medicare.
- Employees have a withholding liability regarding FICA.
- Employers are also responsible for contributing to FICA (they pay for both).
- FICA taxes are usually withheld from FICA.

Health Insurance (Section 1-100)

- In 1973, Congress passed the Employee Retirement Income Security Act (ERISA) regarding health insurance.
