	Sum $f = 20$		Sum $fx_i = 162$

The formula to find the mean is:

$$\text{Mean} = \bar{x} = \frac{\sum fx_i}{\sum f}$$

$$= 162/20$$

$$= 8.1$$

Therefore, the mean number of plants per house is 8.1.
